#### RE: WARREGO HIGHWAY SPEED LIMIT AT WALLUMBILLA SHOWGROUNDS

G'day Tyson

Thank you for your support and attendance at our recent Wallumbilla Showgrounds User Group meeting on 28June 2018. One of the major discussion points at this meeting was the 80km/hr speed limit on the Warrego Highway outside the Wallumbilla Showgrounds. The Wallumbilla Showgrounds host a significant number annual events including Wallumbilla Show, Campdraft, Rodeo and commencing this year State Working Dog Trials. As well as these major events there are regular events including cricket games, Pony Club, Men's Shed and other special functions. This is in addition to the Showgrounds being available for travellers such as caravanners and campers throughout the year and in particular the winter tourist season. When these events are in progress there is a high volume of traffic entering and exiting the Showgrounds from both an Easterly and Westerly direction and it is more good luck that there has been no serious traffic incidents.

There vehicles entering and exiting the Showgrounds range from your average family sedan to road trains and other heavy vehicles. The heavy vehicles are the ones most likely to be involved in an incident due to the fact that they are slower moving and require more time to get onto the highway.

Previously the 80km/h speed zone was located outside the Showgrounds entrance which led to dangerous driving practices where motorists who were increasing speed up to 80km/h did not notice vehicles slowing and indicating to turn into the Showgrounds.

This issue has been represented by the Maranoa Regional Council and the Wallumbilla Showgrounds User groups to the Department of Transport& Main Roads (TMR) to have the 80km/h Speed Zone moved further West so that the entrance was within a 60km/h zone.

Since this representation was made, TMR have moved the 80km/h sign further to the West to their current position and unfortunately this is still not addressing our concerns regarding the safe accessing and exiting of the Showgrounds into a 60km/h zone. TMR made no effort to consult with the community before, during or after the moving of the speed zones. We only became aware of the changes when driving through that area.

On behalf of the Wallumbilla Community Mens Shed Inc I would like gain your support in making representations to TMR to, at a minimu, move the 80km/h sign to the West of the Showgrounds entrance where it was originally requested to moved to.
