The Darling Downs & South West Queensland Council of Mayors (DDSWQ-COM) was formed in October 2015 with the purpose of advocating collectively to achieve priority for the communities' infrastructure and development needs.

The DDSWQ-COM is made up of ten (10) Queensland Councils including:

- Balonne Shire Council
- Bulloo Shire Council
- Goondiwindi Regional Council
- Maranoa Regional Council
- Murweh Shire Council

- Paroo Shire Council
- Quilpie Shire Council
- Southern Downs Regional Council
- Toowoomba Regional Council
- Western Downs Regional Council

At its General Meeting on 13 July 2016, Council approved its continuation of membership and endorsed Mayor Golder as Council's nominated delegate for the 2016 – 2020 term.

Recently, the group Chair, Mayor Antonio has invited Cr. O'Neil's membership on the group moving forwards, in his capacity as the Local Government Association of Queensland (LGAQ) Policy Executive representative for the South West (District 5).

Cr. O'Neil currently represents the interests of Balonne, Bulloo, Murweh, Paroo, Quilpie and Maranoa local government areas and is responsible for the direction of LGAQ's policy.

Local Government Act 2009 Chapter 2

#### 12Responsibilities of councillors

(1)A councillor must represent the current and future interests of the residents of the local government area.

(2)All councillors of a local government have the same responsibilities, but the mayor has some extra responsibilities.

(3)All councillors have the following responsibilities—

(a)ensuring the local government—

(i)discharges its responsibilities under this Act; and

(ii)achieves its corporate plan; and

(iii)complies with all laws that apply to local governments;

(b)providing high quality leadership to the local government and the community;

(c)participating in council meetings, policy development, and decision-making, for the benefit of the local government area;

(d)being accountable to the community for the local government's performance.

#### Section 107 Insurance

(1) A local government must maintain the following insurance-

(a) public liability insurance;

(b) professional indemnity insurance.

(2) The insurance must be for at least the amount required under a regulation.

(3) A local government may enter into a contract of insurance with WorkCover Queensland, or another insurer, to cover its councillors.

(4) For that purpose, a councillor's role includes attending-

(a) meetings of the local government or its committees that

the councillor is entitled or asked to attend; and

(b) meetings for a resident of the local government area; and

(c) conferences, deputations, inspections and meetings at which the councillor's attendance is permitted by the local government; and

(d) official functions organised for the local government.
