**Executive Summary:** This report presents Council with the options for the installation of the Wedge Tailed Eagle Sculpture recently gifted to Council by Injune Arts. The report considers community feedback gathered over two rounds of consultation along with project costings.


# **Officer's Recommendation:**

That Council:

- Receive and note the feedback received throughout both survey rounds
- Select Location 2: Outside the Injune Museum as the preferred site for the installation of the sculpture
- Consider the "Installation of Eagle Sculpture" with a project value of \$13,900 as part of FY25/26 budget deliberations

#### **Context** (*Why is the matter coming before Council?*):

Council recently accepted the donation of a Wedge Tail Eagle from Injune Arts. As part of the resolution, Council requested consultation with the community and staff to establish the preferred location for the Wedge-tailed Eagle within the Injune Multipurpose precinct. Council conducted a survey with 50 responses supplied. The results of the survey are below:

Question 1: Where in the Injune Multi-Purpose Precinct should the sculpture go?




Location 2: Outside the Injune Museum

#### Background (Including any previous Council decisions):

Council conducted a survey to determine the preferred location within Injune for the sculpture purchased by Injune Arts to be installed. There were 134 results from the initial survey with 56 votes in favour of the Injune Multi-purpose precinct.



Injune Arts purchased the Wedge-Tailed Eagle from the 2024 Sculptures Out Back exhibition which was donated to council on 27 November 2024.

# **Options Considered:**

Lighting: Solar Lighting was considered along with traditional hardwired installation by a qualified electrician. Commercial grade solar lights were considered providing gentle and soft lighting. These lights have adjustable angles, and 12 hours of charge will be sufficient for 7 days of lighting. Solar light example below. Cost \$399 each from Sunshare solar.



Foundation/Mounting: Traditional concrete foundation was considered the only suitable mounting method based on ease of maintenance. **Cost for foundations** – 3m round concrete slab with steel edging - \$5148.00 3m round crusher dust ring with steel edging - \$3905.00

Installation requirements:	Option 1 (Library)	Option 2 (Museum)
Lighting - hardwired	\$6,000	\$8,000
Foundation - Concrete	\$5,148	\$5,148
Transport & Installation	\$700	\$700
Total:	\$11,848	\$13,848

There is opportunity to reduce this project cost should Solar lighting options be deemed suitable. This would save approximately \$4300 off the library mounting option and \$6300 off the museum mounting option.

# **Recommendation:**

That Council:

- Receive and note the feedback received throughout both survey rounds
- Select Location 2: Outside the Injune Museum as the preferred site for the installation of the sculpture
- Consider the "Installation of Eagle Sculpture" with a project value of \$13,900 as part of FY25/26 budget deliberations.

# Budget / Funding (Current and future):

There are currently no open grant rounds which Council can apply for to assist with the installation of this eagle. There is opportunity to partner with a local community group to fundraise or apply for grants.

The costs of the two options considered are summarised in the table above. There is an option to reduce the upfront installation costs by electing to use solar lights. This would save on installation and running costs however further scrutiny is required to ensure the specified solar lights will be adequate for the project. Should Council elect to adopt the project as part of overall budget adoption, any project savings would be returned to Council.

# Timelines / Deadlines:

The installation of the Wedge Tailed Eagle sculpture is of keen interest to the Injune community. There would be opportunity to wait and apply for suitable grant funding opportunities however this would be the least preferred option given the relatively low estimated project cost.

#### Consultation (Internal / External):

Injune Arts Injune Community (survey) Injune Local Area Director Injune Local Development Officer Arts and Culture Officer Sculptures Out Back – Local Area Director met with leaders of the Sculptures Out Back committee to gather their feedback on the preferred installation location. It was reiterated that the selected location should capture the 'grandness' of the sculpture and it should be adequately lit in a place of prominence. It was discussed that a location in front of the Injune Hall would be suitable.
