#### **Executive Summary:**

Proposed amendment to the meeting commencement time for the ordinary meeting on 25 September 2025.

#### Officer's Recommendation:

That Council adjust the meeting commencement from 9am to 1pm for the ordinary meeting on 25 September 2025.

#### **Context** (Why is the matter coming before Council?):

Proposed amendment to the meeting commencement time for the ordinary meeting on 25 September 2025. The meeting is currently scheduled to commence at 9am. It is proposed that the meeting instead commence at 1pm.

This change is proposed to allow Councillors, should they wish, to attend a Community Sporting Expo in Roma on the morning of Thursday 25 September 2025.

- (b) for a particular meeting—at another place fixed by the local government, by resolution, for the meeting.
